## 1. Select your membership status. (Check One)

- ASSOCIATE MEMBER: (Retired Individuals)** Any person who was previously engaged in the newspaper profession is eligible to apply for an associate membership. If such application is approved by the Board the applicant shall become an associate member upon the payment of dues as determined by the Board. (Art. III, Sec. 1 (B) OPA By-Laws)
- SUSTAINING MEMBER: (Corporations other than legal newspapers)** Any person, corporation or organization engaged in furnishing machinery, equipment, supplies or services to business members or who is otherwise interested in the welfare of the newspaper profession is eligible to apply for a sustaining membership. If such application is approved by the Board, the applicant shall become a sustaining member upon the payment of dues as determined by the Board of Directors. (Art. III Sec. 1 (C) OPA By-Laws)

A publication that is not a legal newspaper may apply for sustaining membership if it fulfills the following requirements:

- 1) Published once per month for 24 consecutive months                      2) Each issue contains at least 25% news content
